Subject: Updated: COVID-19 Vaccine and Administration Codes

The <u>FDA has approved and authorized for emergency use</u> updated <u>Moderna</u> and <u>Pfizer-BioNTech</u> COVID-19 vaccines for ages 6 months and older. These vaccines, formulated to more closely target currently circulating variants and provide better protection against serious consequences of COVID-19, are effective as of 9/11/2023. The vaccines have been updated to include a monovalent (single) component that corresponds to the Omicron variant XBB.1.5.

Effective October 3rd 2023, the FDA has approved and authorized for emergency use the updated Novavax vaccine for ages 12 years and older. The vaccine has been updated to include a monovalent (single) component that corresponds to the Omicron variant XBB.1.5. The code for this vaccine has an updated rate of \$130.00 in effect as of 10/3/2023.

The federal government is no longer purchasing these COVID-19 vaccine products.

Vaccines for children through 18 years of age are provided through the Vaccine for Children Program at no charge. The SL modifier is used when billing for these free vaccines through this program. Administration fees are paid by Medicaid. Out of state providers should bill for these codes without the SL modifier.
